TBL Frederick "Name the Team" Contest

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

The object of the "Name the Team" Contest ("Contest") is to collect votes for an original team name for the TBL Basketball team in Frederick, MD ("Team Name"). TBL Frederick will also collect submissions to be considered as the team name. TBL Frederick ownership and management ("Judges") will evaluate the Eligible Entries (defined below), as well as consider the fan vote results in conjunction with the Judges' scores to determine the official team name (defined below).

ELIGIBILITY

The Contest is only open to legal residents of All states who are eighteen (18) years of age or older, and have a valid e-mail address and internet access as of the time of entry ("Participant"). Employees, officers, and directors (and their immediate family members) of TBL Frederick ("Sponsor") are eligible to vor for and or submit a Team Name but are not eligible to be selected as the Grand Prize Winner ("Entry Only Participants").

The Contest is subject to all applicable federal, state, and local laws and regulations. This Contest is void outside of All states and where prohibited or restricted by law. Purchase of products from Sponsor will not improve an Eligible Participant's chance of winning.

CONTEST PERIOD

The Contest begins on August 13, at Midnight Eastern Time ("ET") and ends on September 9, at 4:00 ET (the "Contest Period").

HOW TO ENTER

- 1. **Online Method:** During the Contest Period, Participants may go to <a href="https://fearthebeast.com/name-the-team/](https://fearthebeast.com/name-the-team/] (https://fearthebeast.com/name-the-team/) and click on the banners, buttons and/or links to access the online entry form for the Contest. Eligible Participants will be automatically entered in the Contest upon submission.
- 2. **Mail-in Method:** As there's no physical address provided for mail-ins, this method is not available for this contest.

All entries must include a valid e-mail address for the Participant. All information submitted by Participants is subject to, and will be treated consistently with, the

https://fearthebeast.com/name-the-team/ Terms of Use and Privacy Policy. Multiple entries are allowed; however, only one (1) vote or submission per entry is allowed. Incomplete and/or inaccurate entries are void. Online Participants who do not click their agreement to these Official Rules will not have their entries reviewed. Entries that

do not comply with the submission requirements, the Content Restrictions, or otherwise with these Official Rules will be void, eliminated, and not eligible for consideration.

JUDGING

The Judges will evaluate each Eligible Entry submitted based on the following criteria: (1) originality (20%), (2) creativity (20%), (3) uniqueness (20%), (4) regional relevance (20%), and (5) appropriateness for audience (20%). On or about September 9, the Judges will determine the top two (2) Eligible Entries based on the foregoing judging criteria and place them into consideration with the predetermined name voting options. During the period beginning on or about Midnight ET and ending on Midnight ET (the "Voting Period"), fans will have the opportunity to vote for their favorite of the top five (5) Eligible Entries at https://fearthebeast.com/name-the-team/. Limit one (1) vote per fan during the Voting Period. Additional votes beyond the specified limit will be void. Votes or email addresses generated by script, macro, or other automated means or with the intent to affect the integrity of the voting process will be void. At the end of the Voting Period, the Judges will consider the fan vote results in conjunction with the Judging Criteria scores to determine the potential official team name. Following the official name announcement on September 9th, 2023, five (5) submissions and/or votes will be chosen at random for the official Grand Prize. Winners are subject to verification of eligibility and compliance with the terms of these Official Rules, the potential Grand Prize winners will be declared the official Grand Prize winners of the Contest (the "Grand Prize Winners"). TBL Frederick does not guarantee the winning Team Name will be used and is under no obligation to use the winning Team Name; TBL Frederick reserves the right to use any of the submitted Team Names or none at all.

All Participants must provide a valid e-mail address at the time of entry. If multiple entries are made from the same e-mail address, only the first entry received will be considered, and any subsequent entries will be rejected. Any Team Name that does not comply with the foregoing, in the sole discretion of TBL Frederick, will be disqualified and eliminated from consideration.

The potential Grand Prize winner will be notified by e-mail by TBL Frederick with instructions regarding acknowledgment of and claiming the Grand Prize. If the potential Grand Prize winner does not respond to any such notification by providing the requested information within three (3) business days after receipt of the e-mail, the potential Grand Prize winner will be disqualified and no longer eligible to receive the Grand Prize. If a disqualification results, an alternate potential Grand Prize winner may be chosen based on the judging criteria and fan vote results as set forth above from among the remaining Eligible Entries; the alternate potential Grand Prize winner must comply with the same requirements as the original disqualified potential Grand Prize winner to be eligible to receive the Grand Prize.
